Mindpass, Inc. (a Delaware Corporation) ("Mindpass", "we", "us", or "our") operates and provides our users (each user, "you") with the Mindpass password management tool, (the "App"), as well as a number of related services enabled via the App (collectively, the "Services"). The following terms and conditions (the "Agreement") form a binding agreement between you and us regarding your use of the App and Services. Please read this Agreement carefully before accessing or using our Services. By accessing or using any part of our services, you agree to become bound by the terms and conditions of this agreement. If you do not agree to all the terms and conditions of this agreement, then you may not access or use any of our services. If these terms and conditions are considered an offer by Mindpass, acceptance is expressly limited to these terms. Our Services are not directed to children younger than 13, and access and use of our Services is only offered to users 13 years of age or older. If you are under 13 years old, please do not register to use our Services. Any person who registers as a user or provides their personal information to our Services represents that they are 13 years of age or older. Use of our Services may require a Mindpass account. You agree to provide us with complete and accurate information when you register for an account. You will be solely responsible and liable for any activity that occurs under your username. You are responsible for keeping your password secure.

1. Mindpass

Your Mindpass Account and App. To use our Services, you must download the App (unless the App has been pre-installed on your computer or mobile device), register online or through the App and set up an account (an "Account") with us. Your Account will be linked to your App which is accessed separately by following the instructions in the App, and remembering your collection of images (the "Images"). Your Account may be for a free version, a "freemium

version" (e.g., temporary access to premium features for free) or for a premium version. Each version may have different features enabled and you will only be enabled to use the features applicable to the version you have registered for. You agree to be responsible for any act or omission of any users that access the Site or Services under Your Account. Payment and Renewal. General Terms. Optional paid services such as device sync are available (any such services, an "Upgrade"). By selecting an Upgrade you agree to pay Mindpass the monthly or annual subscription fees indicated for that service. Payments will be charged on a pre-pay basis on the day you sign up for an Upgrade and will cover the use of that service for a monthly or annual subscription period as indicated. Automatic Renewal. Unless you notify Mindpass before the end of the applicable subscription period that you want to cancel an Upgrade, your Upgrade subscription will automatically renew and you authorize us to collect the then-applicable annual or monthly subscription fee for such Upgrade (as well as any taxes) using any credit card or other payment mechanism we have on record for you. Your permission to use the Site is conditioned upon the following use, posting and conduct restrictions:

You agree that you will not under any circumstances:

- access the Service for any reason other than your personal, non-commercial use solely as permitted by the normal functionality of the Service,
- collect or harvest any personal data of any user of the Site or the Service
- use the Site or the Service for the solicitation of business in the course of trade or in connection with a commercial enterprise;
- distribute any part or parts of the Site or the Service without our explicit written permission (we grant the operators of public search engines permission to use spiders to copy materials from the site for the sole purpose of creating publicly-available searchable indices but retain the right to revoke this permission at any time on a general or specific basis);
- use the Service for any unlawful purpose or for the promotion of illegal activities;
- attempt to, or harass, abuse or harm another person or group;
- use another user's account without permission;
- intentionally allow another user to access your account;
- provide false or inaccurate information when registering an account;

- circumvent, disable or otherwise interfere with any security-related features of the Service or features that prevent or restrict use or copying of content, or enforce limitations on use of the Service or the content accessible via the Service; or
- publish or link to malicious content of any sort, including that intended to damage or disrupt another user's browser or computer.

2. Mindpass, the App. Description

The App is a password management tool that allows you to generate repeatable password hashes at the time of use. Your passwords are automatically hidden or removed upon exiting the browser or using the clear function on The App. Selecting your Mindpass in the App enables The App to generate your passwords for the pages you visit. You may create passwords using the App (the “Create and copy a Mindpass for external applica- tion”) that are less likely to be hacked than simple passwords people commonly use. However, we make no guarantees regarding the security of any password the Password Generator creates. Mindpass is not liable for your inability to use any site (or third party mobile app) resulting from your use of the App.

Ownership. By using the App, you agree that Mindpass and its licensors own all rights, title and interest included in the Services, including all content, data, information, text, software, sound, photographs, graphics, video, messages, tags and/or other materials accessible through the App, excluding the images that are all in the public domain. You will not remove, alter, or obscure any copyright, trademark, service mark or other proprietary rights notices incorporated in or accompanying the App.

Your Account. Notwithstanding anything to the contrary herein, you acknowledge and agree that you shall have no ownership or other property interest in your Account, and you further acknowledge and agree that all rights in and to your Account are and shall forever be owned by and inure to the benefit of Mindpass.

Access. If you lose access to your Mindpass account or forget your Mindpass, you may not be able to generate your passwords. We are not responsible for any information lost in the App.

Prohibited Uses. When using our Services, you agree not to:

- Publish material or engage in activity that is illegal under applicable law.
- Use the App in any way to compromise our Services, as determined by us in our sole discretion.
- Disclose the sensitive personal information of others.
- Send spam or bulk unsolicited messages.
- Interfere with, disrupt, or attack any service or network.
- Distribute material that is or enables malware, spyware, adware, or other malicious code.
- License, sell, rent, lease, reproduce, resell, transfer, assign, distribute host or otherwise commercially exploit any content found in our Services, conduct or promote any illegal activities while using our Services, reverse engineer, disassemble, decompile, or translate or jeopardize the correct functioning of our Services, or otherwise attempt to derive the source code of the software (including the tools, methods, processes, and infrastructure) that enables or underlies our Services, attempt to gain access to secured portions of our Services to which you do not possess access rights, use any automatic, electronic or manual process to harvest information from our Services (including without limitation robots, spiders or scripts), impersonate any person or entity, or otherwise misrepresent your affiliation with a person or entity; or

If Mindpass believes, in its sole discretion, that you have violated or attempted to violate these conditions or the spirit of these terms, your ability to use and access our Services may be temporarily or permanently revoked, with or without notice.

3. Responsibility of Users

This Agreement does not transfer from Mindpass to you any Mindpass or third party intellectual property, and all right, title, and interest in and to such property will remain (as between the parties) solely with Mindpass. Mindpass, the App, the Mindpass logo, and all other trademarks, service marks, graphics and logos used in connection with our Services, are trademarks or registered trademarks of Mindpass or Mindpass's licensors. Other trademarks, service marks, graphics and logos used in connection with our Services may be the trademarks of other third parties. Your use of our Services grants you no right or license to reproduce or otherwise use any Mindpass or third-party trademarks.

6. Changes

We are constantly updating our Services, and that means sometimes we have to change the legal terms under which our Services are offered. If we make changes that are material, we will let you know by posting on one of our blogs, or by sending you an email or other communication

Mindpass shall have no liability for any failure or delay due to matters beyond their reasonable control. The foregoing shall not apply to the extent prohibited by applicable law.

10. General Representation and Warranty

You represent and warrant that (i) your use of our Services will be in strict accordance with the Mindpass Privacy Policy, with this Agreement, and with all applicable laws and regulations (including without limitation any local laws or regulations in your country, state, city, or other governmental area, regarding online conduct and acceptable content, and including all applicable laws regarding the transmission of technical data exported from the United States or the country in which you reside) and (ii) your use of our Services will not infringe or misappropriate the intellectual property rights of any third party.

11. US Economic Sanctions

You expressly represent and warrant that your use of our Services and or associated services and products is not contrary to applicable U.S. Sanctions. Such use is prohibited, and Mindpass reserves the right to terminate accounts or access of those in the event of a breach of this condition.

12. Indemnification

You agree to indemnify and hold harmless Mindpass, its contractors, and its licensors, and their respective directors, officers, employees, and agents from and against any and all claims and expenses, including attorneys' fees, arising out of your use of our Services, including but not limited to your violation of this Agreement.

13. Translation

These Terms of Service were originally written in English (US). We may translate these terms into other languages. In the event of a conflict between a translated version of these Terms of Service and the English version, the English version will control.

14. Miscellaneous

This Agreement constitutes the entire agreement between Mindpass and you concerning the subject matter hereof, and they may only be modified by a written amendment signed by an authorized executive of Mindpass, or by the posting by Mindpass of a revised version. Except to the extent applicable law, if any, provides otherwise, this Agreement, any access to or use of our Services will be governed by the laws of the state of Delaware, U.S.A., excluding its conflict of law provisions, and the proper venue for any disputes arising out of or relating to any of the same will be the state and federal courts located in Delaware. The prevailing party in any action or proceeding to enforce this Agreement shall be entitled to costs and attorneys' fees. If any part of this Agreement is held invalid or unenforceable, that part will be construed to reflect the parties' original intent, and the remaining portions will remain in full force and effect. A waiver by either party of any term or condition of this Agreement or any breach thereof, in any one instance, will not waive such term or condition or any subsequent breach thereof. You may assign your rights under this Agreement to any party that consents to, and agrees to be bound by, its terms and conditions; Mindpass may assign its rights under this Agreement without condition. This Agreement will be binding upon and will inure to the benefit of the parties, their successors and permitted assigns.
